Mayor Derrick Mostella called the Council meeting to order at 6:06pm on Tuesday, February 16, 2021. Teleconference was also available pursuant to the Proclamations of the Governor of the State of Alabama declaring a State of Emergency in the State due to COVID19 and for the essential minimum functions of government or in response to the COVID -19 State of Emergency.
